**BOMET COUNTY SUPPLEMENTARY
APPROPRIATION ACT, 2014**

[Date of Assent: 22nd May 2014]

[Date of Commencement: 22nd May 2014]

AN ACT of the County Assembly to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the year ending on the 30th June, 2014 and to appropriate those sums for certain public services and for connected purposes

ENACTED by the County Assembly of Bomet, as follows—

Short title and
Commencement.

1. This Act may be cited as the Bomet County Supplementary Appropriation Act, 2014 and shall commence upon assent.

2. The Bomet County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the financial year ending 30th June, 2014, the sum of Kenya Shillings Three Billion Seven Hundred and Ninety Nine Million, Nine Hundred and Forty Eight Thousand, Four Hundred and Twenty Four and that sum shall be deemed to have been appropriated as from 1st July, 2013, for the services and purposes specified in the Schedule.

3. There may be applied for the several services and purposes specified in the Schedule, in addition to the sum granted under section 2, the sums specified out of any money directed to be applied as appropriations in grant from the national government.

4. The supply granted for the services for the year ending 30th June 2014 in accordance with Appropriation Act, 2013 is reduced by Kenya Shillings Twenty One Million Eight Hundred and Fifty One Thousand Five Hundred and Seventy Six.
